1. Course description

Semesters: 2.

Scope: total number of hours -180, including: lectures -24 hours, practical -48 hours, independent work -108 hours; number of ECTS credits -6.

Course objectives – mastering theoretical and practical knowledge of the basic provisions of the theory and practice of financial management.

Learning outcomes of the course:

know: the essence and functions of financial management; organization of financial management at the enterprise; financial management strategy and tactics; organizational and information support of financial management; the nature and types of cash flows of the enterprise; cash flow management tools; methodical tools for estimating the value of money over time and its application in financial calculations; theories of capital structure; investment management tools at the enterprise; modern concepts of risk management;

be able to: forecast cash flows of the enterprise; identify the impact of factors on the final financial result of the enterprise; analyze financial risks; forecast cash flows to ensure the stable operation of enterprises; to form a strategy for effective allocation of financial resources of the enterprise; use budgeting to increase the competitiveness and investment attractiveness of the enterprise; manage receivables of the enterprise; manage the company's inventories; control the effectiveness of anti-crisis financial management, determine the impact of anti-crisis measures based on the financial parameters of the enterprise;

be able to demonstrate: ustification of the need for investment resources; skills of forming a real investment program; methods of finding reserves to strengthen the financial condition of the enterprise; ability to substantiate methods of neutralization and external insurance of financial risks; ways to form a system of organizational and information support of financial management at the enterprise;

have the skills of: to perform tasks on realization of strategy of development of financial divisions of the enterprise, on anti-crisis financial management of the enterprise; application of basic methods of analysis and planning of enterprise assets; skills to assess the main financial risks in certain types of financial transactions and areas of financial activities of enterprises;

independently solve: problems of financial management; ethical dilemmas based on the rule of law, ethical principles and universal values.

Required educational components (prerequisites, co-requisites, post-requisites): enterprise finance, foreign language of professional orientation, cost-oriented financial management, financial diagnostics, analysis and control, financial evaluation, bank management, insurance management.

Course content: Topic 1. Theoretical and organizational foundations of financial management. Topic 2. The system of financial management. Topic 3. Cash flow management in the enterprise.

Topic 4. Determining the value of money over time and its use in financial calculations. Topic 5. Profit management. Topic 6. Asset management. Topic 7. Cost and optimization of capital structure. Topic 8. Investment management. Topic 9. Financial risk management. Topic 10. Analysis of financial statements. Topic 11. Financial forecasting and planning in the enterprise. Topic 12. Anti-crisis financial management at the enterprise.

Forms of final control: exam (semester 2).

Tools for diagnosing learning success: individual tasks, questions for current control, tests, tasks, calculation works, questions for final control.

Language of instruction: Ukrainian.

3. Course policy:

- 3.1 Mandatory observance of academic integrity by students, namely:

- without good reasons, the student is sent for retaking with a minimum score.
- 3.5 When plagiarism is detected, it is returned for revision, and then re-assessed for minimum scores.
- 3.6 Missed classes are worked out according to the agreed schedule.
- 3.7 Assessment appeal is possible with a written request of the student on the day of the announcement of the final assessment results. Assessment appeal takes place at a meeting of the commission, headed by the head of the department.
