1. Course description

Semesters: 2.

Scope: total number of hours -90, including: lectures -12 hours, practical -24 hours, independent work -54 hours; number of ECTS credits -3.

An aim of course: it is the acquisition by students of a system of special knowledge in the field of combating money laundering, terrorist financing and proliferation of weapons of mass destruction, practical skills of applying this knowledge in relevant areas of financial activities.

Learning outcomes of the course:

know: the need to combat the legalization of proceeds of crime and the financing of terrorism and the proliferation of weapons of mass destruction; stages of development of international relations in the field of combating money laundering and major international organizations in this field; the essence and typology of legalization of proceeds from crime; basic international norms in the field of combating money laundering and terrorist financing; essence and types of financial monitoring; the mechanism of functioning of the financial monitoring system in Ukraine; rights and responsibilities of financial monitoring entities; liability for violation of the law to prevent and combat money laundering or terrorist financing and proliferation of weapons of mass destruction;

be able to: identify financial transactions with signs of unusualness, doubt and others, which are aimed at using the financial institution in the scheme of legalization of proceeds from crime, or terrorist financing and proliferation of weapons of mass destruction;

have the skills to: apply the rules of legislation on financial monitoring and the fight against terrorist financing and the proliferation of weapons of mass destruction; risk assessment methodology for a financial institution - the subject of primary financial monitoring, which can be used for money laundering "Dirty" funds or terrorist financing and proliferation of weapons of mass destruction;

able to demonstrate: features of the organization of financial monitoring by various subjects of primary financial monitoring;

independently solve: problems of financial management; ethical dilemmas based on the rule of law, ethical principles and universal values.

Necessary educational components (prerequisites, co-requisites and post-requisites): methodology of modern scientific research with the basics of intellectual property; Business Foreign Language; security theory of social systems; comprehensive financial security; financial monitoring; change management.

The content of the discipline. Tema 1. Formation of a global system of financial monitoring. Tema 2. International anti-money laundering and anti-terrorist financing system. Tema 3. Typical schemes of money laundering, terrorist financing and the threat of proliferation of weapons of mass destruction. Tema 4. Typical domestic money laundering schemes. Tema 5.

International regulations in the global system of financial monitoring. Tema 6. Domestic legal framework for combating money laundering, terrorist financing and proliferation of weapons of mass destruction. Tema 7. Organization of the fight against money laundering by individual subjects of primary financial monitoring in Ukraine.

Forms of final control: exam (semester 2).

Means of diagnostics of learning success: individual tasks (abstract), list of questions (for final

control), set of test tasks (for final control).

Language of instruction: Ukrainian.

3. Course policy:

- 3.1 Mandatory observance of academic integrity by students, namely:

- 3.7 Assessment appeal is possible with a written request of the student on the day of the announcement of the final assessment results. Assessment appeal takes place at a meeting of the commission, headed by the head of the department.
