#### 1. Course description

Semesters: 7.

**Scope**: total number of hours -90, including: lectures -12 hours, practical -12 hours, independent work -66 hours; number of ECTS credits -3.

**Course objectives** – formation of students' theoretical knowledge and practical skills in the organization of financial planning and the application of its methodological tools.

#### **Learning outcomes of the course:**

know: the essence of financial planning, its purpose, functions and significance as an integral part of the overall management system of the enterprise; methodological principles and methodological tools of financial planning, the specifics of application, advantages and disadvantages of financial planning methods; methodological principles and methodological tools of financial forecasting, the specifics of application, advantages and disadvantages of financial forecasting methods; methodological principles and methodological tools of business planning, structure and sequence of business plan; about methodological bases and methodical tools of current financial planning, structure and sequence of drawing up of budgets of the enterprise; methodological principles and methodological tools of operational financial planning; methodical methods of forecasting the financial condition of the enterprise;

be able to: apply the regulatory framework governing the financial planning system; use theoretical knowledge and practical skills in the implementation of financial management and financial planning; to find reserves for improving the activity of the enterprise, to assess the level of material support by types of insurance; carry out current, operational, strategic and business planning and forecasting of the financial condition;

be able to demonstrate: skills in operational, current and strategic financial planning and forecasting in enterprises;

have the skills of: use of methodological tools for financial planning and forecasting of business entities:

*independently solve:* questions on the choice of criteria and mastering the methods of financial planning and forecasting of enterprises and financial institutions.

Required educational components (prerequisites, co-requisites, post-requisites): enterprise economics, microeconomics, statistics, money and credit, finance, enterprise finance, foreign language of professional orientation, statistics.

**Course content:** Topic 1. Financial planning and forecasting in the financial management system. Topic 2. Methodical tools of financial planning. Topic 3. Methodical tools of financial forecasting. Topic 4. Basics of business planning. Topic 5. Current financial planning. Topic 6. Operational financial planning. Topic 7. Basics of forecasting the financial condition of enterprises.

Forms of final control: exam (semester 7).

**Tools for diagnosing learning success:** tasks (for current control), list of questions (for modular and final control), sets of test tasks (for modular and final control).

Language of instruction: Ukrainian.

#### 3. Course policy:

- 3.1 Mandatory observance of academic integrity by students, namely:

- for good reasons (sick leave, academic mobility, etc.) the work is submitted during the semester or at the end of the semester and is assessed according to the level of work performance;
- without good reasons, the student is sent for retaking with a minimum score.
- 3.5 When plagiarism is detected, it is returned for revision, and then re-assessed for minimum scores.
- 3.6 Missed classes are worked out according to the agreed schedule.
- 3.7 Assessment appeal is possible with a written request of the student on the day of the announcement of the final assessment results. Assessment appeal takes place at a meeting of the commission, headed by the head of the department.
