Course purpose - mastery of competencies: the ability to carry out activities in the interaction of the subjects of market relations; ability to identify and perform professional tasks to organize the activities of business, trade and exchange structures; ability to do business planning, assess market conditions and performance in the field of entrepreneurship, trade and exchange practices, taking into account risks.

Learning outcomes of the discipline: *to know:* basics of business planning, assessment of market conditions and performance of business, trade and exchange structures, taking into account risks;

3. Course policy:

- for good reasons, the work is evaluated without reducing the maximum score, provided that the teacher is notified in advance or through the head of the group (documentary) about the reason for the delay and the deadline for the transfer of work;

- without good reason - with a decrease in the maximum score for work performed.

3.5. When plagiarism is detected, the work is not credited, another individual task or another version of tests for current (thematic) and modular control is issued. The maximum score is reduced for a new job.

3.6. Missed classes necessarily need to be worked out according to an individual schedule agreed with the teacher.
