1. Course description

Semester: 2

Scope: total number of hours - 180, including lectures - 24 hours, practical - 24 hours, independent work - 82 hours; term paper - 50 hours, number of ECTS credits - 6.

Course objectives – mastering competencies/abilities - acquisition by future managers competencies of effective management of economic entities taking into account the market situation.

Learning outcomes of the course:

know: subjects and objects of economic development; macroeconomic indicators, economic relations between the subjects of society, the proportions of social reproduction; economic, organizational, legal and social issues that arise in the process of enterprise management;

be able: systemically evaluate results of economic entities management; analyze the existing level of security of the enterprise and its types on the basis of the collected primary information; identify the main types of threats to the safe operation and development of economic entities; identify internal sources of risks for the functioning of economic entities; to conduct an objective analysis of the effectiveness of management decisions on the creation and implementation of programs (measures) to improve the management of economic entities;

able to demonstrate: ability to predict and critically assess possible directions of enterprise and entrepreneurship development in conditions of risk and variability of the external environment; ability to develop strategic development plan of economic subjects, taking into account the dangers and threats of their activities; ability to control the implementation of proposals to eliminate identified shortcomings, violations and threats in the management of economic entities;

have the skills: collect, process and interpret information used in management decisions to improve business management economic entities; apply the latest scientifically sound methods, techniques, tools, approaches to improve the level of management of economic entities;

solve independently: issues of forecasting and critical assessment of enterprise and entrepreneurship development in terms of risk and variability of the external environment; strategic planning of development of economic entities taking into account dangers and threats of their activity; control over the implementation of proposals to eliminate the identified risks, shortcomings, violations and threats in the management of economic entities; making effective management decisions in a changing environment.

Required educational components (prerequisites, co-requisites, post-requisites): methodology of modern scientific research with the basics of intellectual property; strategic management of innovative development; change management; creative management, master's thesis.

Course content: Topic 1. The essence, subject and tasks of managing the activities of economic entities. Topic 2. Subjects of economic activity. Topic 3. Fundamentals of organizing the activities of economic subjects. Topic 4. The place of economic strategy in the management of economic subjects. Topic 5. Risk management of production and financial activities of economic subjects. Topic 6. Monitoring and analysis of the effectiveness of management decisions to create and implement a program of measures to improve the management of economic subjects.

Forms of final control: examination (semester 2), course work (semester 2).

Tools for diagnosing learning success: individual tasks, questions for current control, tests, tasks, questions for final control.

Language of instruction: Ukrainian.

3. Course policy:

- 3.1. Mandatory observance of academic integrity by students, namely:
